3. reasoning behind data collection, data processing or data usage

4. concerned persons rights

In addition, you have the right to restrict processing according to Art. 18 DSGVO, a notification in connection with the rectification or erasure of personal data or the restriction of processing according to Art. 18 DSGVO and the right to data portability according to Art. 20 DSGVO. You may also lodge a complaint with a supervisory authority according to Art. 77 DSGVO.

5. right of objection
